Australian Unity Limited announces completion of Series C Australian Unity Bonds – Tranche 1 and Series D Australian Unity Bonds – Tranche 1 offer raising A\$322.0 million

Australian Unity Limited (Australian Unity) has successfully completed its offer of Series C Australian Unity Bonds – Tranche 1 and Series D Australian Unity Bonds – Tranche 1 (Bonds), raising a total of A\$322.0 million (Offer). The Offer has resulted in Australian Unity issuing 1,150,192 Series C Australian Unity Bonds and 2,070,000 Series D Australian Unity Bonds at A\$100 each.

The proceeds of the Offer have been used to refinance the Series B Australian Unity Bonds that participated in the Reinvestment Offer and will also be used for general corporate purposes.

Trading on ASX

The Bonds were issued today, 15 October 2019, and are expected to begin trading on a normal settlement basis on the ASX on 18 October 2019. Series C Australian Unity Bonds and Series D Australian Unity Bonds will trade under the ASX codes 'AYUHC' and 'AYUHD' respectively.

Allocation policy

All valid applications received under the Member Offer and the Reinvestment Offer were accepted in full.

Allocations to Syndicate Brokers and Institutional Investors were determined following the bookbuild completed on 13 September 2019.
