Australian Unity Funds Management Limited as responsible entity of the Australian Unity Childcare Property Fund ("CPF") considers that CPF is a withholding managed investment trust ('withholding MIT') and an attribution managed investment trust ('AMIT') in relation to the income year ended 30 June 2024.

The following estimated components are provided solely for the purposes of determining withholding MIT non-resident withholding tax under Subdivisions 12A-B and 12-H of Schedule 1 to the Taxation Administration Act 1953 (Cth) ('the Act') (for fund payments) and Subdivisions 12A-A and 12-F of the Act (for dividend, interest and royalty payments) in respect of the period 01 Oct 2023 to 31 Dec 2023, and should not be used for any other purpose.

For the purposes of Subdivisions 12A-B and 12-H of the Act, this distribution includes a 'fund payment' amount of 0.3926 cents per unit in respect of the period 01 Oct 2023 to 31 Dec 2023.
