Sale of Lot 11, 133 South Pine Road, Brendale, QLD

On 23 March 2023, the Fund exchanged contracts of sale for the property located at Lot 11, 133 South Pine Road, Brendale, QLD. The agreed sale price was \$6.30 million which is a 22% premium compared to the property's most recent book value. Settlement of the property is scheduled to occur in late April 2023 (or earlier by mutual agreement).
