# Target Market Determination Australian Unity Property Income Fund



# Introduction

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). # Target Market Summary

This product is intended for use as a satellite component within a portfolio for a consumer who is seeking capital growth or income distribution and has a high to very high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with an investment timeframe of at least 5 years and needs access to capital within one week of the request.
