The buy spreads/sell spreads aim to ensure that existing investors don't bear costs incurred by the Fund due to investor applications or redemptions.

- Buy spreads are extra costs applied on entry to the Fund. It is an estimate of the costs that the Fund incurs (such as brokerage, agent fees, legal fees, stamp duty and taxes) when buying additional assets due to an investor's application.
- Sell spreads are costs applied on exit from the Fund. It is the Fund's estimate of the costs that the Fund incurs when sellingdown assets to pay investor redemptions.
- The buy spreads/sell spreads are not paid to us, but are retained in the Fund to cover those transaction costs; and
- The buy spreads are not applied to the reinvestment of distributions.

We may change the buy spreads/sell spreads from time to time without prior notice. If the buy spreads/sell spreads changes, we will notify you via our website Altius Asset Management – Australian fixed interest manager (altiusam.com).
