## Australian Unity Diversified Property Fund – ARSN 106 724 038

### Property revaluations

Three properties in the Fund's portfolio were independently valued during December 2017. Overall, valuations increased by approximately \$3,774,615 or 2.98% from the properties' book value immediately prior to valuation. The material variations included:

**Dogswamp Shopping Centre, WA** – The independent value of Dogswamp Shopping Centre, increased in value by \$2,563,199 or 6.04% from the property's book value immediately prior to valuation. The increase was due to capitalisation compression as a result of the completion of the redevelopment and the new 15 year lease to ALDI supermarkets.

**Woodvale Boulevard Shopping Centre, WA** – The independent value of Woodvale Boulevard Shopping Centre, increased in value by \$1, 217,893 or 4.38% from the property's book value immediately prior to valuation. The increase was attributable to capitalisation compression as a result of the buoyant transactional market.

At 31 December 2017 the Fund's gearing ratio was 41.97% with gross assets at \$330.80 million and total borrowings of \$138.83 million.
