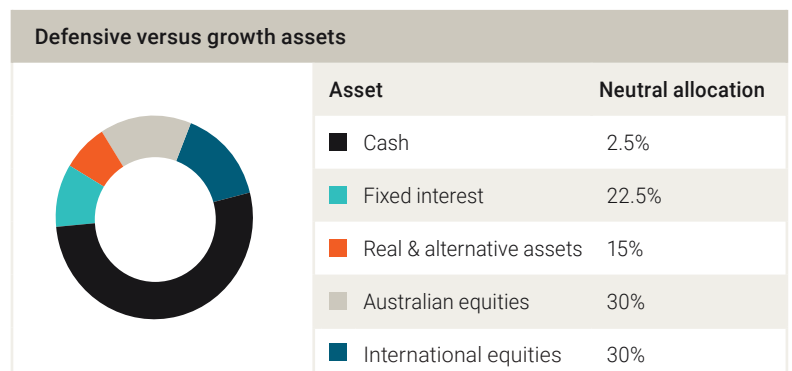
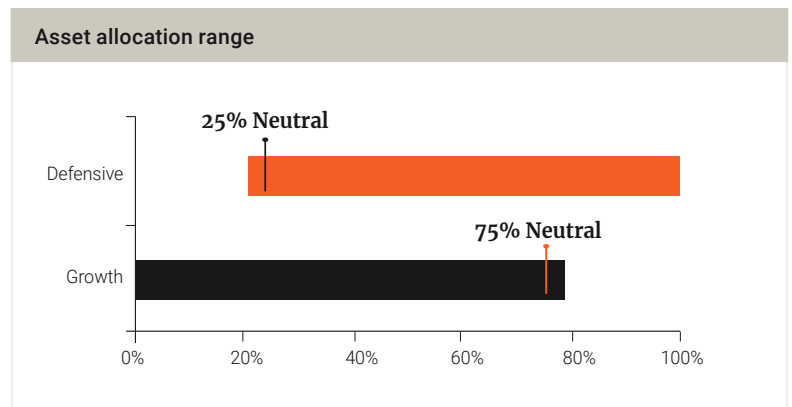
## A simple, cost-effective investment solution that takes a 'growth' approach
