Target Market Summary

This product is likely to be appropriate for a consumer seeking **capital preservation** to be used as a **core or satellite component** within a portfolio where the consumer has a **medium or long** investment timeframe, **low** risk/return profile and needs **daily** access to capital.

Investment products and diversification

For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. Daily		Under normal circumstances unit holders can withdraw from the Fund daily by providing a withdrawal request. Withdrawals are generally paid within five business days although, under the constitution for the Fund, we have up to 21 days to satisfy withdrawal requests. The Fund is therefore likely to be appropriate for a consumer who needs the ability to lodge a withdrawal request on any given business day. Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product to reduce volatility and minimise loss in a market down-turn. The consumer prefers exposure to defensive assets (such as cash or fixed income securities) that are generally lower in risk and less volatile than growth investments.
Capital Guaranteed	The consumer seeks a guarantee or protection against capital loss whilst still seeking the potential for capital growth (typically gained through a derivative arrangement). The consumer would likely understand the complexities, conditions and risks that are associated with such products.
Income Distribution	The consumer seeks to invest in a product designed to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (typically, high dividend-yielding equities, fixed income securities and money market instruments).
