This product is likely to be appropriate for a consumer seeking **capital growth or income distributions** to be used as a **core or satellite component** within a portfolio where the consumer has a **medium or long** investment timeframe, **high to very high** risk/return profile and needs **daily** access to capital.

The Fund sells exchange traded options to generate option premiums which add to the Fund's return. Put option sales are always fully cash backed and call option sales are always fully equity backed. As a result, the Fund does not take on leverage from its use of options. This unique investment methodology harnesses the benefits of consistent income generation and capital appreciation to grow investors' real wealth.

As the Fund will largely hold international equities, by virtue of the nature of these assets being growth assets, the Fund is likely to be appropriate for consumers who are seeking capital growth. As distributions are paid quarterly, it is also likely to be appropriate for consumers who are seeking income distribution.

Solution/Standalone (75-100%)		The Fund typically has between 15 and 45 holdings (comprising stocks and options) and can invest up to 100% of its assets in international equities, including direct holdings in shares and option positions over equities, which are fully backed by cash. The Fund may also hold Australian and foreign cash investments. As a result of this, the Fund has medium portfolio diversification and is therefore likely to be appropriate as a core or satellite component of a consumer's portfolio.

Low		The Fund targets higher returns and has a potential for higher losses.
Medium		The Fund's investment strategy aims to produce investment returns through a combination of capital appreciation and income generation. The Fund generally invests in equities that the investment manager believes are trading at least 20% under their intrinsic value. As such, a percentage of returns are produced from the market realising the investment manager's value view and the Fund's shareholdings appreciating. The Fund is therefore likely to be appropriate for consumers who have a high or very high risk and return profile.

Daily		Under normal circumstances unit holders can withdraw from the Fund daily by providing a withdrawal request. Withdrawals are generally paid within five business days although, under the constitution for the Fund, we have up to 21 days to satisfy withdrawal requests. The Fund is therefore likely to be appropriate for consumers who need the ability to lodge a withdrawal request on any given business day. Capital Growth	The consumer seeks to invest in a product designed to generate capital return. The consumer prefers exposure to growth assets (such as shares or property) or otherwise seeks an investment return above the current inflation rate.
Capital Preservation	The consumer seeks to invest in a product to reduce volatility and minimise loss in a market down-turn. The consumer prefers exposure to defensive assets (such as cash or fixed income securities) that are generally lower in risk and less volatile than growth investments.
Capital Guaranteed	The consumer seeks a guarantee or protection against capital loss whilst still seeking the potential for capital growth (typically gained through a derivative arrangement). The consumer would likely understand the complexities, conditions and risks that are associated with such products.
Income Distribution	The consumer seeks to invest in a product designed to distribute regular and/or tax-effective income. The consumer prefers exposure to income-generating assets (typically, high dividend-yielding equities, fixed income securities and money market instruments).
