

Student Dependant Registration



Is your child over 23 and eligible to stay on your family cover?

Good news! If your child qualifies as a student dependant, they can remain on your family cover at no extra cost, until they turn 25.

To qualify as a student dependant, your child must be pursuing an approved, full-time course of study or undertaking an apprenticeship, and can't be married or in a de-facto relationship.

To register your child as a student dependant, simply complete and return the Student Dependant Registration Form on the reverse or at **australianunity.com.au/student**

Once registered you need to re-register each year until your child's 25th birthday or until they no longer qualify. We'll send you all the information you need to re-register in March of every year, until your child is no longer eligible. It's also important to notify us if/when their student status changes.

What if they're not eligible to stay on your family cover?

If your child turns 23 (and is no longer studying) or if they are studying and turn 25, they are unable to remain on your family cover.

Once this happens they should take out their own cover as soon as possible, to continue to enjoy all the benefits health cover offers.

If they do so within 3 months of coming off your cover, and the commencement date of their own cover is the day after ceasing to be covered under yours, they won't have to re-serve waiting periods. We'd be happy to have a chat about the best cover for their individual needs.
